Contest Overview

This contest is meant to share in the broader community of leather and pet identity by embracing and empowering all people who identify as a leather person or pet the opportunity to compete. Leather and pet identity is unique to each individual. The judges will evaluate based on how you carry yourself in that identity and not based on how much leather material or gear you wear. This contest is meant to find the individuals who will promote the OKC Eagle Brand and the wider community. Judges will be looking for those who place community, outreach, advocacy, and inclusivity at the forefront of their leather or pet persona. Every contestant is reminded that the term “leather” is not definitive or exclusive of what one wears, but rather who they are; and their authentic expression inside the leather community as a whole. This contest is designed to allow the judges to find an individual who best embodies their own identity of leather and/or pet and who they believe is best to be an ambassador of the OKC Eagle and the LGBTQ+ leather, pet, kink, and fetish community.

The Judged portions of the event will include the following:

1. Interview
2. Bar Wear with contestant introduction and tag line
3. Pop Question with Fantasy Wear
4. Leather or Pet Image with Speech

Contestant Eligibility

All contestants must:

- Be 21 years of age or older with valid government ID reflecting age of contestant.
- Must be an Oklahoma Resident within 75 miles of the OKC Eagle. Exceptions to this rule may be made in limited situations upon application and appeal to producers if applicant can demonstrate their frequency of support for the OKC Eagle through their presence, or other means at a minimum of twice per month for a period of the last 2 years. This exception will be at the sole discretion of the producers and director of the OKC Eagle Contest.
- Must provide two high resolution photos for purposes of social media marketing that is free from copyright protection and can be utilized by the OKC Eagle and Producer Team.
- Contestants must not have any violent felony or sexual felony convictions or pending charges defined by Oklahoma Statute and are precluded from running for the title with the conviction or pending charges of a violent/sexual felony. No contestant may have a conviction for any form of intimate partner assault, battery, assault and battery, or intimate partner threats of violence. Contestants actively on felony probation; including deferred probation are precluded from being a contestant. Contestants must disclose any criminal convictions and current probationary terms on their application and failure to

disclose will result in disqualification. Contestants with prior convictions (including misdemeanor probation/convictions) which are not precluded from competing as outlined above may be contacted by the producer team to discuss any potential eligibility concerns; and may be subject to ineligibility to compete based on the decision of the Eagle and the Producers.

- Contestants will be ineligible to run if they have competed and won or made a podium placement in their application category (podium placement will be considered as 2nd and 3rd place whether a contest has a public podium ceremony past announcing a title winner or not) in the year 2026 for a national or regional title prior to the start of the OKC Eagle contest date of August 28, 2026. Contestants will give permission to the producer team to inquire about placement of the regional or national contest competed in. Questions will be limited to if won, or placed 2nd or 3rd only based on that titles criteria for placements order including if points were made to qualify for placement.
- Pay the \$35 contestant fee on August 28, 2026 at mandatory contestant meeting.

Each individual category of eligibility is reflected below:

Mr. Oklahoma City Eagle Leather contestant must:

- identify as male or male-identifying individual, 21 years or older.
- Understand this is a leather contest that is reflective of individual identity as a person of leather.

Ms. Oklahoma City Eagle Leather contestant must:

- identify as female or female-identifying individual, 21 years or older.
- Understand this is a leather contest that is reflective of individual identity as a person of leather.

Oklahoma City Eagle Pet contestant must:

- identify as male/female/non-binary-identified individual, 21 years or older.
- Understand this is a pet contest that is reflective of individual identity as a pet.

Title Winners Winnings

Winners will receive a backpatch, legacy sash for the duration of their title year, a weekend stay package at the District Hotel and Resort to be used within their title year, and a travel fund to be determined by sale of door fees, auction items, and sponsorship donations. The Legacy Sash will have the winner's name placed on the back upon the end of their title year.

Contestant Expectations

The winner of Oklahoma City Eagle Title Contest is expected to represent the Oklahoma City Eagle and associated events including, the District Hotel and Resort brands to the best of their ability.

That would include:

1. To promote the Oklahoma City Eagle Title and contest locally, statewide, nationally, and/or internationally when possible.
2. To plan and coordinate, either jointly (with 2026 OKC Eagle Title Family) or individually, at least four (4) Charity fundraising events. One event must be coordinated with the Austin Eagle as part of the OKC Eagle and Austin Eagle collaboration project. .
3. To make a minimum of six (6) additional public appearances as the 2026 Oklahoma City Eagle Title at events of leather, fetish, or LGBTQ+ during the title year.
4. To attend 2027 OKC Kink Weekend, (highly encouraged to educate or volunteer) and assist in coordination and promotion of the 2027 Mr./Ms./Pet Oklahoma City Eagle contest.
5. To maintain good standing in the community by presenting themselves with integrity.
6. Maintain a high level of professionalism while wearing contest sash, back patch, and/or other title affiliated attire (ex: avoid excessive intoxication, no inappropriate public nudity, etc.)
7. To NOT create or promote a competing contest/weekend event without the consent of The Oklahoma City Eagle.
8. To NOT create commercially available adult content. Including but not limited to Only fans; X; blusky; or other content in a manner that is commercial in value or would reflect negatively on the image and community standing of both the title holder, the OKC Eagle and Title Contest.

Contestant Handler Eligibility

Each contestant is allowed one handler. This person must:

1. Be at least 21 years of age or older as of August 2026.
2. Possess a valid government issued ID, such as a Driver's License or passport.
3. Must be listed on the contestant application.

Contestant Etiquette

1. Complete honesty and full disclosure are expected from all contestants. Any affiliations, issues, or concerns that could reflect poorly on the individual candidates and the Oklahoma City Eagle must be divulged to the Contest Producers immediately. The Oklahoma City Eagle reserves the right to investigate any claims regarding any contestant that could be potentially damaging to the reputation of both the contestant and the Oklahoma City Eagle. The Eagle and producer team also reserves the right to make any determinations and decisions on how to proceed pending the results of their investigations.

2. Any contestant causing damage to the Oklahoma City Eagle venue, inclusive of decorations and equipment, will be immediately disqualified, and may be subject to legal action.
3. Any contestant who is caught in the act of stealing or tampering with another person's gear, or possessions will be immediately disqualified, removed from the location of the contest and denied future participation in the event.
4. The Oklahoma City Eagle has a strict policy against public nudity. Contestants may not expose their genitalia during any part of the weekend. This includes ensuring a covering of the butt crack.

Contestant Handler Etiquette

1. Any contestant handler who is caught in the act of stealing or tampering with another person's gear, costumes, props, or other possessions will be removed from the location of the contests and denied future access to the event. The contestant whose handler is found in violation of this rule will be immediately disqualified.
2. Any contestant handler who is caught causing damage to the Oklahoma City Eagle venue, including decorations and equipment will be removed from the location of the contest and denied future access to the event.
3. Contestant handlers must abide by all request of OKC Eagle Staff, Producers, and contest staff. Handlers will only be allowed in the pre-staging area and is not allowed on stage with the contestant not allowed to provide hand gestures, cues, or interference that assists or distracts their contestant or another.
4. Handlers are encouraged to assist with clothes changes, being moral support, and providing assistance as needed for their contestant only.
5. Handlers should conduct themselves with professional courtesy and respect of all the contestants.

Policy on Drugs and Alcohol

Any contestant who is found to be grossly intoxicated or under the influence of drugs in public shall be disqualified. Additionally, any individual while wearing an Eagle Leather sash, back patch or any other titleholder regalia may be stripped of their title and awards forfeited. Contestants are welcome to enjoy social outings and should be responsible regarding their social reputation while representing the title.

Judging

The Judging Panel will consist of seven judges. The judging panel will be comprised of members of the LGBTQ+ and Leather/pet community. This includes judges who are both local (OKC Metro) leaders and advocates along with some non-OKC metro leaders and advocates. The OKC Eagle Contest will utilize the Olympic scoring method. In this method the highest and lowest scores are dropped from the tally. The remaining scores are then added together to

determine a contestant score for the category. Once each category has been scored, the scores for all categories are added together to make your total score. A contestant must make 70% of total eligible points to be considered for the title. The individual with the highest score for each title group will determine the winner, and the individual with the second highest score for each title group will be considered the runner up. In the event of a tie individual category scores will determine the winner. The category score order will be as follows: Leather Image or Pet Image and Speech; Interview; Pop Question and Fantasy Wear; Bar Wear with tag line. In the event that there was to be a tie amongst all categories for the winner and the runner up then the highest and lowest numbers that were excluded per the Olympic scoring system will be added back into the averages to determine the winner.

Category Scoring and Descriptions

1. Interview: (Maximum score of 750 points)

Each contestant will be interviewed by the panel of judges prior to the on-stage portion of the contest. Questions may range from contestants' personal history, occupation, life experience, and social affiliations to personal and political opinions about current events topics, etc. Judges' questions often cover knowledge of the leather and pet community; its leaders and history; and the Contestant's contributions and/or leadership in the leather community.

Judges will be looking at the character, charisma, and personality of each contestant. It will also provide them with the opportunity to evaluate basic skills and qualities such as intellect, communication capabilities, attitude and composure. Contestants should attend the interview in an outfit that best represents who their authentic image is. This could be their everyday bar wear to any outfit that best describes their authentic leather or pet image. (Keep in mind no nudity or exposure of genitals/cracks). Contestants should remember this is a professional, yet casual, interview. Attire should reflect personality while remaining relaxed and comfortable and something that is suitable for attendance at a public social event. The interview schedule will be conducted in contestant order number. Each interview will be 12 minutes. Additionally, contestants must remain in the pre-staging interview space until all contestants have been interviewed. The interviews are not open to the public for viewing and contestant handlers may not attend the interview portion but may remain in the pre-stage space.

2. Bar/Social wear with contestant self-introduction and tag line: (maximum score of 500 points)

Bar/Social wear is a chance for the contestant to show the judges who they are with their leather/pet gear. This should be what you would regularly wear to the bar/social outing and should represent your leather or pet aesthetic or persona. Contestants should be cognizant of how their gear fits, what it looks like, grooming standards, and will be judged on all aspects of the appearance and the stage presence aspect of their time on stage.

Contestants will be brought in as a group after the opening number of the hosts. Contestants will then be asked to step to the mic and introduce themselves. Your introduction should consist

of Name, contestant category they are competing in, what area of the metro they are from and a one sentence tag line describing themselves or their platform. Once you have introduced yourself you will step back into line. The Hosts will dismiss you to prepare for the next category.

Example: "Good evening, I am Pup Spot, competing for OKC Eagle Pet from Mustang. I may look spotted, but I actually got my name because I know how to find all those good spots." (This should take no longer than 30-45 seconds per contestant.)

3. Pop question with fantasy wear: (Maximum score of 500 points)

This is the time to show off a little skin while still maintaining the image of one's leather or pet identity. This is not a "body contest" but rather how comfortable and confident you appear in your own skin. Wear your favorite fantasy wear or gear (keeping in mind that no genitals/crack or nudity at all) This is your opportunity to model and perform and just let loose and have fun. Contestants will be brought on stage one by one. A Portion of their application will be read for the audience. The Contestants will be asked to strut their stuff during the reading of this portion of their application; this will include the more fun and personal bio such sexual interests, position, hanky codes etc. The Contestant will then be asked to draw a question to be answered by them during the pop-question portion of this category. Questions can be about leather, pop culture, LGBTQ+ culture, etc. Most questions in the box will likely be spicy and designed to let you get creative in your answer. The question will first be read by them silently then read twice by the show hosts. The mic will be handed to the contestant to answer the question. Contestants will have 1 minute to answer the question, and time will start the moment they touch the mic from the host. (this category is timed please see the penalties section below regarding time portions of the contest) Set-up time is not provided; no set props may be used. No items may be left on the stage upon exiting. Judging will be looking for how confident you are on stage in your fantasy gear. They will also judge your response to the question. They will not be about how correct the answer is, but how you choose to answer. This is your chance to win over the crowd with your personality.

4. Leather or Pet Image with speech: (Maximum score of 750 Points)

This is the last category and chance to impress the judges with your leather or pet image. While often referred to as the formals portion of the contest; this category is more an opportunity as a contestant to put on your best and most authentic leather or pet image look. Additionally, to your best leather or pet image look you will be asked to give a 90 second speech to the crowd. Each contestant will be brought on one by one by contestant number. The contestant application portions regarding community involvement and contributions will be read to the audience, giving you another opportunity to model your look.

Contestants will then be asked to give a speech no longer than 90 seconds long. This is a speech that best reflects who you are as person of leather or pet, your personal platform or why they want to be the OKC Eagle Title Holder. (this category is also timed please see penalties section regarding timed portioned of the contest). Judges will be looking for the overall

appearance of each contestant in their best leather or pet image. This includes how the appearance looks and grooming considerations, the contestant's attitude and overall appeal in their leather or pet look. Judges will also be evaluating the speech portion of the category paying particular attention to the speech's sincerity and personalization. Set up time is not provided; no set props may be used, and no items may be left on the stage upon exiting.

Category Maximum scores reflect the maximum available points by utilizing the Olympic scoring method. Scores dropped due to Olympic scoring method will only come into play in the event of a tie across all categories for determining a winner and runner up. Category scoring will only be compared amongst each individual title group.

Penalties

Penalties at the contest can be reflected in two ways. First, a contestant who goes over the prescribed time allotted in the speech and pop question scored categories will receive penalty deductions. The penalty deduction received in these category specific areas will be deducted off the combined score average of the particular category the penalty was incurred. The following is the point deduction per second over time:

Seconds over	Points Deduction
1-5	1 point
5-10	5 points
10-15	10 points
15-20	15 points
20-25	20 points
25-30	25 points
30+	Contestants will receive 0 points for the category

Call times for the contest are firm to ensure timely start and appreciation for all people's time and energy to the contest. Contestants who arrive late to call times will face administrative point deductions against their overall combined score. A contestant who arrives 5-10 minutes late to their call time will receive a 1-point deduction. Contestants who arrive 10-15 minutes late will receive a 5-point deduction. A contestant who does not arrive by the official start time of a judged category will be deemed to have withdrawn from the contest and disqualified.

Addendums and Handbook/Rule Changes

The owners of the Oklahoma City Eagle and Producer team reserve the right to make amendments to the Contest Handbook at any time. All contestants will be notified where the amended Contest Handbook may be accessed and the date they will take effect within 48 hours of amendment. Any matter not covered by this Contest Handbook shall be addressed immediately and any necessary decisions will be decided by the Producers and OKC Eagle owners, or another designated representative of the Oklahoma City Eagle.

Contestant Schedule of Events

This schedule is tentative and may be subject to change as contest gets closer

Friday, August 28, 2026

7:30PM - Call Time for Contestant Meeting

8:00PM - Contestant Mandatory Meeting (location to be determined)

This is a non-judged meeting. This meeting will include rules of the contest and discuss any additional housekeeping issues or concerns. This will be the last opportunity for the Contestants to review their publicly read portions of the application. Contestants should arrive prepared to transition to the Meet and Greet event that begins at 9 and will include a public drawing of contestant numbers.

9:30- Meet and Greet at the OKC Eagle

This is a non-judged event. This is the first opportunity for judges and contestants to mingle and get to know each other. The event will include a public drawing of the contestant numbers.

Saturday August 29, 2026

8:30 AM – Interview Arrival Call time

9:00AM – Interviews

Contestant interview will begin at 10 am. Interviews will be 12 minutes per contestant. Contestants are required to remain in the interview preparation space until all contestants have interviewed.

1-3:30 PM – Club Aquatica Splash Party

This is a non-judged Mandatory Event. Contestants will be expected to attend and assist with the Splash Party including the promotion of the fundraising event of food, drinks, and games during the event.

4pm - SMART Recovery Meeting (non-mandatory event)

6:00 PM – Call time

7:00 - Contest Starts

The Oklahoma City Eagle contest will have the following categories judged during the main portion of the contest:

Bar Wear - with tag line

On stage pop question and fantasy wear

Leather or Pet image with Speech (90 second speech)

Each section of the contest will have entertainment between sets, so each contestant has time to change. Entertainment will include performances by members of the community; and the hot wear and gear auction.

11:00 PM – 2AM **OKC Eagle Title Winners Victory Party** with after hours party starting at 2am at Club Aquatica.
